Request for Information: Freedom of Information Act

Thank you for your email of 11 December, making a request for information under the Freedom of Information Act. You requested the following information and the Trust is able to provide the information below in response:

Request:

This is a Freedom of Information request regarding usage of certain products in all NHS Trusts, these products are:

- Iloprost 0.5mg/0.5ml Ampoules
- Melatonin 1mg/ml oral solution,
- Melatonin 2mg Capsules,
- Melatonin 3mg Capsules,
- Melatonin 5mg Capsules,
- Melatonin 3mg Tablets
- Mexiletine 200mg capsules
- Diazoxide 50mg/ml oral suspension

Response:

The Trust are able to provide quantities or costs, but not both as this would disclose prices per pack which are commercially confidential. The Trust is unable to comply with your request in full and has

applied section 43 and section 41 to the request. The Trust has not disclosed this information and relies on section 43 in this respect. The Trust would not be able to obtain best value in tendering, negotiating or contracting for these products and services, and there would be likely to be prejudice to the commercial interest of the Trust and providers of such products and services as a result.

2017 figures do not include December's data.
