Request for Information: Freedom of Information Act

Thank you for your email of 3 April, making a request for information under the Freedom of Information Act. You requested the following information and the Trust is able to provide the information below in response:

Request:

Just to note we have recently asked you for the following information but for the years 2014-15, 2015-16, 2016-17, which you have fulfilled. We would now like the latest data for 2017-18. (If you have not yet sent us the information for years 2014-15, 2015-16, 2016-17 please do so alongside the information listed below.)

1. How many CAMHS referrals have you had from education settings from April 1 to March 31, 2017-18?

(By education setting I mean: Local Authority maintained schools, academies, independent schools and alternative provision, including but not limited to, Pupil Referral Units).

2. Of those referrals how many were not eligible for support and how many went on to receive treatment?

3. Please provide a breakdown of the ages of all children and adolescents referred by education settings (11 and under; 12-15; 16 and over)

4. What age was the youngest child referred by an education setting?

5. For those who were offered treatment, what broad category did the primary diagnosis fit into:

(a) Life threatening conditions

(eg. Psychosis; risk of suicide or severe self-harm; severe depressive episode; anorexia nervosa)

(b) Conditions leading to severe functional impairments

(e.g.) compulsive disorder (OCD); Anxiety/phobic/panic disorders; Bulimia nervosa; ADHD where there is significant psychiatric co-morbidity; Autistic spectrum disorders; Tourette's syndrome; School refusal where mental health disorder plays a significant role; Conduct difficulties which co-exist with other disorders; Severe and/or complex relationship difficulties

(c) Children and young people with learning disabilities experiencing emotional or behavioural or mental health difficulties

(d) Emotional difficulties relating to physical conditions (e.g. Diabetes; Asthma; Neurological conditions; Unexplained pain/ somatising disorders

(e) Early intervention to prevent the development of more severe disorders

(e.g. Complicated bereavement; Post-traumatic stress disorder (PTSD); Severe attachment difficulties; Self-care issues

5. When a child or adolescent is not eligible for support in CAMHS do you signpost them to other potential sources of help? (If yes, please specify).

If my request looks too time consuming please just answer questions 1, 2 and 3.

The Trust is unable to comply with section 5 as individual record review would be required to derive the information and this would require the Trust to exceed the appropriate limit. There are in excess of 2000 individual patient records to review, which at a minimum of 1 minute per record would take the Trust at least 30 hours. The appropriate limit set in regulation by section 12 of the Freedom of Information Act is 18.

If you are unhappy with the service you have received in relation to your request and wish to make a complaint or request a review of our decision, you should write to me and I will ensure the decision is reviewed. The Trust will consider undertaking a review if requested to do so within 40 working days of the date the response is received by the applicant, and will apply discretion if a longer period of time has passed.

Should you wish to make a complaint as a result of the outcome of such a review, you may apply directly to the Information Commissioner's Office (ICO) for a decision.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by the Trust for FoI Act matters.
