Request for Information: Freedom of Information Act

Thank you for your email of 13th April, making a request for information under the Freedom of Information Act. You requested the following information and the Trust is able to provide the information below in response:

Request

I would like to request information, under the Freedom of Information Act, regarding the information technology (IT) spending at your trust for each of the past three financial years (2015-16, 2016-17, 2017-18). If you are unable to provide the figures this period please provide them for financial years where this information is available.

Please include all IT spending at the trust, to the greatest extent practicable, including both spending on staff and external suppliers, internally funded projects and projects funded with additional central funding (such as global digital exemplar or test bed programmes), unless otherwise specified. Please feel free to include an explanatory notes that highlight the scope of data provided.

Bearing the above in mind, please provide the following:

- 1. For each financial year, the total information technology (IT) budget if held, please split into capital and revenue budget.
- 2. For each financial year, actual IT expenditure if held, please split into capital and revenue expenditure.
- 3. For each financial year, total external funding provided to the trust for IT projects and the source for that funding (e.g. NHS England) if held, please split into capital and revenue expenditure.
