## **Request for Information: Freedom of Information Act**

Thank you for your email of 9<sup>th</sup> November, making a request for information under the Freedom of Information Act. You requested the following information and the Trust is able to provide the information below in response:

## Request:

I would like you to send me the locum agency spend in the AHP/HSS division of the hospital for Occupational Therapists and Physiotherapists in acute settings as well as the community. I would like to know the spend from January 2018 - present, also including the amount of locums that this refers to per month, broken down on a monthly basis. In the breakdown if you could please include the agencies that provide the locums also broken down numerically.

Ideally this would read as below -

January 2018 - £20k Community - £16k Acute
Sugarmans - Occupational Therapists x 3
Just OT - Occupational Therapists x 2
RIG - Physiotherapists x 2
Maxxima - Physiotherapists x 2
Sugarmans - Physiotherapists x 2
Then a breakdown all the way to as present as possible.
If you could provide this either in a PDF or excel format.
